The purpose of this Circular is to inform Metropolitan Police Department (MPD) members that effective Monday, October 18, 2010, the District of Columbia Department of Motor Vehicles (DC DMV) changed the color of the Dealer Identification tag.

The new Dealer tag design has a **YELLOW** background, **BLACK** numbers, a numbering series displayed as DLR 0000, and the D.C. stars and bars logo. The expiration date of 10/31/11 is printed in both top corners. The tag also reads "DEALER" at the bottom. (See Attachment A.)

The new designs were issued to dealers beginning October 18, 2010. As of October 31, 2010, any vehicle displaying the old, expired design [**CYAN** /Dealer] is invalid.

Members are further advised that dealership owners are allowed to operate a vehicle displaying a Dealer Identification tag if they carry a Dealer Proof of Registration Card. (See Attachment A.) Their salespersons may operate a vehicle displaying a Dealer Identification tag if they carry their valid salesperson's license. Customers of the dealership may operate a vehicle bearing Dealer tags for up to five (5) days if a Temporary Registration Certificate is affixed to the windshield of the vehicle. (See Attachment A.)

NOTE: DC DMV no longer issues "Manufacturer Tags."
