Emergency Traffic Posts

The purpose of this order is to provide a quick reference for the establishment of emergency traffic posts during times of heavy snowfall, flooding, power outage, and other similar adverse conditions which may disrupt the normal flow of traffic. This order consists of the following part:

PART I Responsibilities and Procedures for Supervisory and Command Personnel

PART I

A. Listing of Emergency Traffic Posts.

1. Attachment "A" is a list of all emergency traffic posts that are to be controlled in cases of emergency. This list indicates, in order of priority, all the major intersections and certain trouble areas usually affected during emergency traffic situations.

2. Attachment "B" concerns responsibility of the United States Park Police and the United States Capitol Police for areas noted and is provided for informational purposes only.

B. District Commanders Responsibility.

Commanders shall, when ordered by proper authority, require the intersections within their respective area to be covered as emergency traffic posts so as to ensure a continuous flow of traffic throughout the city at all times. This responsibility shall also extend to monitoring the flow of traffic over all bridges and freeways in their respective districts.


C. Commander, Traffic Division.

The Commander, Traffic Division, shall coordinate with the Commanders of the First and Second Districts as to which intersections will be covered by Traffic Division personnel.

D. Additional Manpower.

Due to the large number of posts in certain districts, it may at times become necessary for commanding officers to request a detail of additional manpower.
