A. General Order 304.1 (Procedures for Conducting Investigations) is amended to read as follows:

"PART II

A. Criminal Investigations Division.

The Criminal Investigations Division shall be responsible for conducting and completing investigations of the following offenses:

1. All deaths (except traffic)(Homicide Branch).
2. Criminal Abortions and Attempted Criminal Abortions (Homicide Branch).
3. Arson (when property damage exceeds \$5,000.)(Burglary, Arson, and Pawn Section).
4. Bigamy (Sex Offense Branch).
5. Blackmail (Check and Fraud Section).
6. Bombings (including found incendiary devices and bomb threats) (Burglary, Arson, and Pawn Section).
7. Bribery (Check and Fraud Section).
8. Burglaries (Over \$2,000 and those concerning outside jurisdictions or agencies or those which are part of a crime pattern or those involving hotels, motels, or financial institutions) (Burglary, Arson, and Pawn Section).
9. Embezzlement (Check and Fraud Section).
10. Extortion (Robbery Branch).
11. False pretenses (all bad check cases) (does not include petty larceny by trick) (Check and Fraud Section).

12. Forgery (Check and Fraud Section).
13. Fugitives (Major Violators Section).
14. Incest (Sex Offense Branch).
15. Armed robbery, attempted armed robbery, and conspiracy to commit armed robbery (Robbery Branch).
16. All robberies or attempted robberies of Federally insured institutions, federal facilities, and armored cars (Robbery Branch).
17. Kidnapping (Robbery Branch).
18. Rape (Sex Offense Branch).
19. Seduction and Seduction by a Teacher (Sex Offense Branch).
20. Forcible sodomy and sodomy with a juvenile (Sex Offense Branch).
21. Assault with intent to commit either murder, rape, burglary, armed robbery, or kidnapping.
22. Threats against public officials (Robbery Branch).
23. Indecent acts with children (Sex Offense Branch).

B. District Investigations Sections.

District Investigations Sections shall be responsible for conducting follow-up investigations and subsequent follow-up reports as follows:

1. All felonies not specifically assigned to the Criminal Investigations Division.
2. Coordination with and participation in those investigations of a serious nature that are assigned to the Criminal Investigation Division provided:
 - a. The District Commander has specifically instructed the District Investigative Section to become involved.

- b. The assigned member of the District Investigative Section has notified the appropriate branch of the Criminal Investigations Division.
- c. The District Commander may require the assigned member to complete a follow-up report on the investigation, a copy of which shall be forwarded to the appropriate branch of the Criminal Investigations Division.


3. Rendering prompt assistance and guidance to uniform personnel in the preparation of reports and investigation of all offenses which may require further investigative activity by investigative personnel.

B. General Order 308.9 (Procedures for Handling Armed Robberies (other than street robberies)) is amended by:

- 1. Removing the phrase "(other than street robberies)" from the title and
- 2. Removing the phrase "(other than street robberies)" from the first paragraph.

C. General Order 101.10* (Organization of the Metropolitan Police Department) is amended as follows:

- 1. Part IIB2a shall read:
 - "a. Investigate all armed robberies and attempted armed robberies, any robbery of a federally insured institutions, federal facilities, armored cars, kidnappings, extortions, and obscene, harassing, or threatening telephone calls to federal or local government officials."
- 2. Part IIB3 is amended by changing "abortions" to "criminal abortions".
