DESCRIPTION OF WANTED PERSON OR MESSAGE PROCEDURE CHANGE FOR REQUESTS TO VIEW CCTV IMAGES <p>It will no longer be necessary for detectives to submit a written request through the chain of command in order to view CCTV images. When a detective has reason to believe that a criminal offense may have been recorded by a CCTV camera, the detective may contact a SOCC official directly and verbally request to view the recording. The detective shall provide the SOCC official with all of the information necessary to identify the recording location, date, time period, CCN, etc.</p> <p>It shall be the responsibility of the SOCC official to document the request using the form "Viewing Recorded CCTV Feed," obtain the recording for viewing, and notify the detective when the recording is available for review. The SOCC will continue to maintain the central file of all CCTV viewing requests; organizational elements will no longer be required to maintain a duplicate file. The SOCC official will provide the detective with a copy of the completed viewing request for the case jacket.</p> <p>Part V-K-2 of Special Order 06-12 (Enhanced Use of CCTV To Combat Crime) which requires a request to view recordings be submitted in writing to the commanding official of the SOCC is hereby rescinded.</p>
