15. DESCRIPTION OF WANTED PERSON OR MESSAGE

In June 1999, the U.S. District Court of Appeals found the Juvenile Curfew Act of 1995 to be constitutional. In an effort to ensure the health and safety of young people and our communities, the MPD began enforcing the Juvenile Curfew Act of 1995. Special Order 99-14 was established to ensure procedural guidelines were followed.

Special Order 99-14, Part VI, Section C, #1 & #2 –Transporting Curfew Violators Home is replaced in its entirety with:

- **1. If the juvenile is under the age of 13, the Watch Commander shall be contacted and the juvenile transported immediately to the Child and Family Services Agency.**

Members shall transport the violator to the Child Family Services Agency at 400 6th Street, SW. Curfew hours are - Sunday through Thursday 11:00 p.m. until 6:00 p.m. and Friday and Saturday 12:01 a.m. until 6:00 a.m.
