The officer shall sign the logbook documenting his presence and receive a briefing from the manager on issues and concerns in and around the facility that require law enforcement attention. Additionally, PSA officers shall make themselves available to incidents occurring in an around the recreation centers and make themselves aware of any upcoming activities that may require a police presence. PSA officers shall also notify the District Watch Commander of any significant upcoming events that he/she may have knowledge of that will be occurring at the recreation centers which may require special attention:
