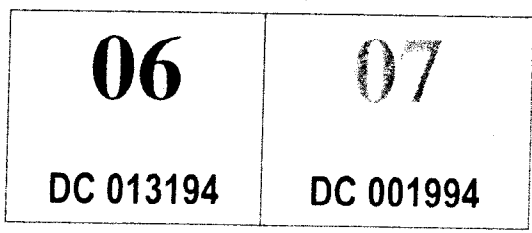
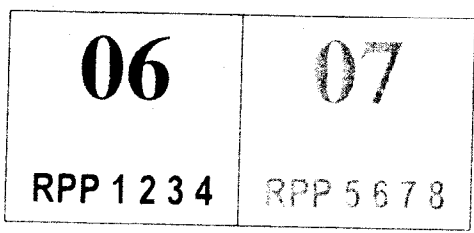

The change generated from many motorcycles not having the ability to adhere the registration/residential-parking sticker to their vehicle. The 2006 Motorcycle decal is DARK BLUE and will reflect RPP 1 2 3 4 or RPP 5 6 7 8 with a hole punched through the qualified residential parking zone. The 2007 Motorcycle decal is GREEN and will reflect RPP 1 2 3 4 or RPP 5 6 7 8 with a hole punched through the qualified residential parking zone. If the customer does not qualify for RPP, they will be issued a 2006 or 2007 tag decal that reflects an inventory control number.
