BACKGROUND:

On May 14, 2008, the Uniform and Equipment board convened and as a result, approved a new "outer vest" body armor cover that can be worn on the outside of the uniform shirt by members with APPROVED medical waivers on file with the Medical Services Division, Police and Fire Clinic [General Order 110.11, Part V, 15 a and f].

ADDITIONAL INFORMATION:


The design for the newly approved outer-vest cover is in production. Completion and readiness for issuance will take approximately four weeks. Jimmie Muscatellos will distribute (via voucher) the outer-vest covers to members with current medical waivers.

Until the new outer-vest cover is distributed, members with medical waivers shall wear their vest with the standard issued navy blue vest cover over top of the outer shirt garment. Members are reminded that they must at all times carry the medical wavier that authorizes this uniform change on their person when wearing the vest in this manner. Moreover, members are reminded that the medical waiver must be current and the member must produce the medical wavier to any requesting official.

PROHIBITION:

Note that **ONLY** those members assigned to plain clothes or tactical units are authorized to wear the black tactical outer-body vest cover on the outside of the uniform or plain clothes.

Members can report to Clothing and Equipment for voucher issuance beginning July 7, 2008.
