**MPD UNIFORM CHANGES – BDUs**

The purpose of this teletype is to amend G.O. 110.11, Uniforms and Equipment.

**OPTIONAL MEMBER EXPENSE ITEMS**

Effective, Sunday, July 31, 2005, Patrol Service Area (PSA) personnel the rank of Sergeant and below, and Focus Mission Team (FMT) personnel the rank of Sergeant and below, **assigned to patrol duties**, will be authorized to wear, as a permanent uniform option, at **member's expense**, the Navy Blue Battle Dress Uniform (BDU) while on duty.

**MPD BDU Specifications**

With the exception of the identified units, the BDUs will be purchased at the member's expense and shall conform to Department standards as follows:

Trousers –	Brigade Style #BRT
Long Sleeve Shirt –	Brigade Style #CCS 2504 (Badge holder must be affixed 1" above the left pocket, 1" in width and 2" in length. Eyelets shall be 1 1/8" apart)
8 Point Soft Cap –	Brigade Style #1A

Please note that short sleeve BDU shirts are no longer an authorized uniform item.

**MPD UNIFORM CHANGES – BDUs (contd.)**

**EQUIPMENT AND SUPPLIES BRANCH ISSUED ITEMS**

The following members are authorized to wear navy blue BDUs as an **Equipment and Supplies Branch (ESB) issued uniform item** (three sets): Evidence Control/Property Management personnel, Motorpool, Forensic Science personnel, Equipment and Supplies warehouse personnel, Firearms Training personnel ("Range"), Vehicle Skills trainers, Physical Skills trainers and Cellblock technicians/sworn members.

Emergency Response Team (ERT) members are authorized to wear, and will receive three sets of, **Black BDUs, as an ESB-issued uniform item.**

CDU team members will receive, **as an ESB-issued uniform item**, three sets of Navy Blue BDUs. District Commanders must submit a roster of authorized CDU members to ESB for issue authorization.

Effective October 1, 2005, the Blue Utility is no longer an authorized uniform item.

**APPEARANCE AND WEAR STANDARDS**

The following uniform accessories shall be worn with BDUs and must be in compliance with General Order 110.11:

- Black Leather Administrative Belt with Brass Buckle
- Black Leather Sam Browne Belt
- Black or Navy Blue Socks
- Black Footwear

The MPD and the American Experience Patches **must** be affixed to the BDUs. If BDUs are purchased from the Department's current supplier, Muscatello's Uniforms, a badge holder will be put on the uniform at no additional charge. If other vendors are used these items shall be purchased at the member's expense.

Muscatello's Uniforms is located at 900 Rhode Island Avenue NE. However, BDUs and accessories can be purchased at most police uniform supply stores. Questions should be directed to the Equipment and Supplies Branch, (202) 645-0135.
