AMENDMENT TO TELTYPE # 07-071-05:
MPD UNIFORM CHANGES – PATCHES

Where it reads, "Uniform Board has recommended and Chief of Police has approved 3"x3" patches to be worn below the DC Experience Flag on the left sleeve of the Class B uniform," it should state:

Uniform Board has recommended and Chief of Police has approved 3"x3" patches to be worn below the DC Experience Flag on the right sleeve of the Class B uniform.

AMENDMENT TO TELTYPE # 07-072-05:
MPD UNIFORM CHANGES – BDUs

In the MPD BDU Specification section, where it reads, "Please note that short sleeve BDU shirts are no longer an authorized uniform item," it should state:

Short sleeve BDU shirts will be purchased at member's expense and shall conform to Department standards as follows:

Short Sleeve Shirt – Brigade Style #CCS 904 (Badge holder must be affixed 1" above the left pocket, 1" in width and 2" in length. Eyelets shall be 1 1/8" apart)

Short sleeve BDU shirts are not an authorized uniform item for CDU details. Members serving in a CDU capacity must wear the Department-issued, long sleeve BDU shirt, with the CDU patch affixed to the right sleeve below
