Curfew Enforcement: Youth at The Department of Parks and Recreation Centers

Under the "Juvenile Curfew Act of 1995" (D.C. Code Section 2-1541 et seq.), juveniles attending an official activity sponsored by the District government, or going to, or returning home from such an activity (without any detour or stop), are exempt from the curfew. Juveniles traveling home from a recreation center without any detour or stop are not in violation of the curfew and shall be allowed to proceed home.

The Department of Parks and Recreation (DPR) has 13 recreation centers at which juveniles under the age of 17 will be allowed to stay until midnight. **Any juvenile leaving the below listed recreation centers will be issued a card signed by the Recreation Center Manager, indicating the name of the juvenile, and the date and time the juvenile left the center. Cards will be issued daily.**

The following recreation centers are open, Monday – Saturday, with extended hours until midnight:
