SOFT BODY ARMOR WORN AS AN OUTER GARMENT

Due to medical reasons, the Medical Services Division (Clinic) issues temporary soft body armor waivers, authorizing the wearing of the issued soft body armor as an outer garment. The waiver is valid for 6 months and has an expiration date. Expired waivers are not valid. Members seeking reconsideration or waiver renewals must follow the Clinic directions outlined on the waiver. In addition, members should have their waiver in their possession while wearing the body armor as an outer garment.

Members with waivers have been issued vouchers by the Equipment and Supplies Branch for a "Waiver Vest Cover" and have received a black tactical style vest cover from the clothing and equipment vendor.

The policy of wearing soft body armor as an outer garment is being reviewed by the Uniform and Equipment Board. Pending a ruling by the Board, the wearing of the black tactical style vest cover in lieu of the standard issued vest by those members with a valid body armor waiver and issued voucher shall be considered authorized.
