Alcohol Consumption Policy

To continue to enjoy the trust and ensure the safety of the community and all MPD employees, all members are reminded of the dangers of alcohol consumption and driving. To that end, the following policy shall be effective immediately:

Members (sworn or civilian) may not operate departmental modes of transportation (to include: automobiles, vans, buses, motor scooters, motorcycles, Segways, bicycles, boats, etc.) either on-duty or off-duty after consuming any amount of alcohol or restricted over-the counter (OTC) medications and/or prescription (Rx) drugs which induce drowsiness, sleepiness, or dizziness.

This policy is all-encompassing and includes all departmentally-owned or leased vehicles and all government vehicles operated by MPD employees.

This policy shall remain in effect until incorporated in the appropriate directives.
