Effective May 5, 1992, D.C. Law 9-96 hereby enacted the Comprehensive Anti-Drunk Driving Act of 1991.

The following traffic offenses are now probable case misdemeanors:

1. Reckless Driving (D.C. Code 40-712)
2. Fleeing the Scene of An Accident (D.C. Code 40-417 [a])
3. DUI/DWI (D.C. Code 40-716 [b])
4. Operating After Suspension or Revocation (D.C. Code 40-302 [e])

Members shall make an arrest if there is probable cause to believe that an individual has committed one of the above enumerated offenses. Additionally, the member shall also make the arrest if he/she has reasonable grounds to believe that reliable evidence such as alcohol or drug use may become unavailable (i.e., delay in time could affect the blood alcohol content), or that the person may cause personal injury or property damage (D.C. Law 9-961, Section 5 [b] and [c], amending D.C. Code 23-581 [a]).

Special Order 85.18 (Limitation on Warrantless Arrests for Misdemeanor Traffic Violations) dated April 22, 1985, is hereby rescinded.

Commanding Officers shall ensure that the contents of this message is read at all roll calls for a period of two weeks.
